INTRODUCTION

Since 1873, it has been the mission of The Winnipeg Chamber of Commerce to create an environment in which Winnipeggers can prosper. An attractive environment for economic opportunity is one that provides fair and competitive taxation, seamless regulatory processes, and a qualified workforce within a market area that offers a desirable quality of life.

It is for this reason that The Chamber has taken, and continues to take, an active role in encouraging the City to establish its core mandate, and advocating civic policies and initiatives that will ensure Winnipeg is the most competitive and attractive place to live and do business. Reflecting the overwhelmingly unified view of our members, our efforts have focused on the need to reduce the level of civic taxation and expenditures in order to create a climate conducive to growth and prosperity for all citizens.

In June 1998, a significant public step forward in realizing this goal was made with the release of the Committee on Tax Reform's Report, *Rethinking Taxation – Making Winnipeg Competitive*. Fundamental to the Report is its recommendation that the City must determine:

- what is its core mandate;
- what services does it need to provide in meeting the core mandate; and,
- how can those core services be delivered in the most cost effective and flexible manner.

The Chamber believes this and other recommendations outlined in the Report provide the foundation for the City to begin the task of reducing its expenditures and providing sustainable services to Winnipeg taxpayers.

However, it was extremely difficult in the past to reduce expenditures and taxes given the absence of a core mandate and a complete and detailed identification of what services were being provided by the City. The release of the City of Winnipeg's Management Reference Model for Government Services (MRM), *Focus on Winnipeg Services*, in June 1998 was a truly historic and welcomed event, in that the City now had a detailed report on the full extent of the services it delivers – 260 public and 65 internal services. The Chamber applauds City Council and members of the civic administration for their commitment to making Winnipeg a value-leader across Canada. The MRM Report is a testament to this commitment.

We believe the MRM Report represents the framework that, in conjunction with the Committee on Tax Reform Report, provides the City with the necessary tools to shape its core mandate and address properly the level of civic expenditures and taxation.

Review Methodology

The list of 260 public services outlined in the MRM Report was examined by The Chamber's Civic Services Review Group, as was the list of 65 internal services. Each service was examined using a series of questions provided by the MRM Report (page 14) to help City Council use the MRM information:

- 1. Do the City's programs reflect the needs and aspirations of its citizens?
- 2. Are there any gaps or inadequacies in the City's programs?
- 3. Are there services the City should not be delivering?

From the answers generated by these questions, the next step taken was to determine whether each services was:

- 1. <u>necessary</u> to the operation of the City;
- 2. <u>desirable</u> for a city like Winnipeg, <u>but not critical</u> to the operation of the City; or,
- 3. <u>optional</u> in that the service is not fundamental to the operation of the City and would, at best, constitute a desirable service to a small minority of the population.

Once classified, each service was then examined as to:

- 1. whether it was necessary and/or feasible for the City to deliver the service utilizing civic forces; or,
- 2. whether the service could be better delivered through an alternative delivery mechanism.

The information contained in the MRM Report and in the following review creates a framework for future service-based budgeting and activity-based costing.

General Recommendations

The recommendations outlined in The Chamber review of the *Focus on Winnipeg Services*, as a rule, seek to have the control, design framework, regulation and licensing powers, and supervision of core services remain under the auspices of the City. In doing so, The Chamber believes the City can maintain control over the provision of services to ensure community interests and standards are met while reducing civic service expenditures.

While specific recommendations as to each individual service are contained in the list of public and internal services in the proceeding sections, The Chamber offers the following general recommendations regarding civic departments and options for those services deemed non-essential.

1. <u>Community Services</u>

It is The Chamber's recommendation that a significant number of those services listed under Community Services, particularly those concerning counselling, instruction and training, should be provided by the Province, either through the Departments of Health or Education & Training. Other services, such as those involving leisure facilities, should be considered candidates for either contracting out or other alternative service delivery mechanisms.

2. <u>Emergency Response</u>

In keeping with the practices of many other Canadian urban centres, it is the recommendation of this review that the City of Winnipeg divest itself of all emergency response services with the exception of fire and fire-related services. Of particular note, we believe the provision of medical and ambulance services are the specific responsibility of the Province, or more directly, the Winnipeg Health Authority.

3. Hydro

The existence of two hydro utilities in the Province to provide hydroelectric power to a population of approximately 1.1 million people represents a clear example of duplication and inefficiency. If the City of Winnipeg were starting out today from scratch, there would be little argument for the creation of a separate hydro utility that services a small minority of the civic population with the vast majority of Winnipeg citizens being serviced by the provincial hydro utility.

It is the recommendation of this review that the City sell Winnipeg Hydro.

4. Police

The Chamber recommends police services continue to be provided by the City of Winnipeg.

5. **Property and Development**

In general, The Chamber recommends those services falling under Property and Development continue to be delivered by the City's own forces.

6. Public Works

The Chamber recommends that, in general, Public Works services be contracted out to the private sector with the City retaining those services related to permission and licensing.

7. Social Services

Recommendations pending receipt of updated list of civic services.

8. Transit

It is recommended that Transit services be delivered through a Special Operating Agency (SOA) such as a Transit Authority.

9. Water and Waste

Water and waste services pertaining to consulting, granting, permission and promotion should remain the responsibility of the City to deliver. Other services, with the notable exception of potable water production and distribution, should be contracted out.

10. Internal Services

i) Financial Stewardship

Recommend contracting out the auditing function. All other services to remain the responsibility of the City.

ii) Human Resource Stewardship

Collective bargaining and portions of payroll and benefits administration should be contracted out. All other services to remain the responsibility of the City.

iii) Information Stewardship

iv) Physical Asset Stewardship

CONCLUSION

"We support too many services on property taxes." (Mayor Murray, 1999 State of the City Address)

Today, competition does not confine itself exclusively within the business arena; cities, provinces and countries compete everyday for people, businesses and economic opportunities. In his 1999 State of the City Address, Mayor Murray notes:

"... if we don't realize that in this global economy where cities compete with other cities for intellectual capital and quality of life, if we're not all on the same page and not on the same team we will not succeed."

If Winnipeg is to survive in the global economy, it must be competitive. Having a efficient civic government that offers taxpayers best value for their money must be a cornerstone in any strategy.

"We recognize that citizens invest their tax dollars in our organization. In return, citizens expect value from us...The desire for quality services is seemingly endless in nature. There are not sufficient resources to do all the worthy things that could be done...We know there is little to be gained by spreading our efforts too thin." (Page 11, 'Our Guiding Principles', City of Winnipeg Corporate Plan – March 1999)

The Chamber review follows a philosophy that keeps the control, design framework, regulation and licensing powers, and supervision of core services in the hands of City forces. Management flexibility to ensure the ability of the City to adapt to changing circumstances and cost sensitivity as it relates to expenditures of public funds were equally fundamental to this review process.

Separate reviews of existing City of Winnipeg collective agreements and the system of competitive bidding are being conducted and recommendations to help the City attain these results will be forthcoming in due course.

There are some areas that could potentially be candidates for alternative delivery that we have suggested be left with the City's own delivery mechanism. These are areas that are politically sensitive where the debate over their divestiture could be made so emotional by vested interests, that any proper financial or efficiency examination would be ignored. This could also slow down the implementation of other important changes. These specific services could be examined at a later time, when most of the changes have been completed.

Any service component that can be successfully delivered by the private sector with a financial advantage, or is better suited for a private / public partnership should be dispatched to the most cost effective delivery mechanism. This is also true of some components of the services that would be maintained by traditional City forces. Whenever possible, those services should be provided through a Special Operating Agency (SOA).

The Chamber recognizes that the recommendations outlined in this review will necessitate a reduction of permanent staff at the City and, as a result, has the potential to create some hardships for individuals. While the elimination of some civic services will require an immediate reduction in current staffing, we believe a significant number of the reductions can occur through attrition, volunteer retirement, vacancy management and other alternatives.

The classification of the services in the manner we have done becomes the first step in deciding the core services of the City. The next step is to translate these decisions into future budget preparations.

We believe that the targeted 10% reduction in property tax is but a starting point. Raising additional revenues is not the answer as there is only one taxpayer. The answer rests in redefining core services and better managing service delivery expenditures.

The commitment of citizens to this City and the community of people within it has been tremendous, particularly in the face of the tax burden we all shoulder. However, the patience of citizens has evaporated and, as the 1998 Civic Election so aptly demonstrated, the time has come for immediate and significant cuts in taxes.

It is The Chamber's belief that this core mandate and service delivery review provides Council with the tools with which to begin attaining fiscal and tax competitiveness.
