ACCOMMODATIONS

Accommodation is based on sharing in twin bedded rooms. Single room surcharge applies. In case of a change in hotel due to unforeseen circumstances, Canada One Travel on behalf of its suppliers, reserves the rights to replace with equivalent or better class accommodations.

PAYMENTS

A deposit of **\$500** per person is required at time of booking, fully refundable within 30 days. \$300 non-refundable after 30 days of booking, or Jan 3, 2023, whichever comes first. Final payment due date is **Feb 3**, **2023**. Failure to comply with this requirement will result in automatic cancellation of the reservations and the refund of deposit less cancellation penalties, will be made.



CANCELLATION PENALTIES/ REFUNDS

Refunds, less an administration fee of \$300 per person will be made for cancellations received more than 90 days before departure. Penalties for cancellations made less than 90 days prior to departure will be assessed as follows:

More than 90 days prior to departure \$300 per person 89-60 days prior to departure 25% of tour cost 59-30 days prior to departure 50% of tour cost 29-21 days prior to departure 75% of tour cost Within 21-day of departure 100% of tour cost

After commencement of the tour, no refunds can be given for any hotel accommodation, meals, sightseeing or other items not utilized.
