PARTICIPANTS RESPONSIBILITY

VANCOUVER AIRPORT LOUNGES

The Vancouver airport's international terminal is a pleasant place to relax or shop during your transit.

There is also Plaza Premium Lounge pass for purchase. The use of an airport lounge reduces anxiety and enhances your travel experience. Amenities include drinks, meals, wi-fi, television, magazines, newspapers and shower facility.

You may purchase both outbound and inbound lounge passes.

For outbound, the lounge is in the international terminal providing service up to 12:30am.

For inbound, the lounge service is at the domestic terminal.

ACCOMMODATIONS

All Thailand hotels are local 5 star rated. They not only provide luxury stay and deluxe services, you will always be greeted with courteous and welcoming Thai smiles. Accommodation is based on sharing in twin bedded rooms. Single room surcharge applies. In case of a change in hotel due to unforeseen circumstances, Canada One Travel on behalf of its suppliers, reserves the rights to replace with equivalent or better class accommodations.

PAYMENTS

A deposit of \$500 per person is required at time of booking. Deposit is refundable within 30 days

Package A is priced from Winnipeg. A second deposit payment of **\$2000** deposit will be collected when the tickets need to be issued immediately. The airfare in **A** is a "**through fare**" that gives you the advantage of checking in your luggage and boarding passes from origin to destination (Winnipeg to Bangkok), and vice versa. These seats are **limited**, subject to availability. Balance payment is due 90 days prior to departure.

Package B includes international-only airfare from Vancouver, your final payment is 90 days prior to departure. However, **you do not have the through-fare advantage**. Since your domestic and international tickets are **separate documents**, you are required to check in again (luggage and boarding passes) in Vancouver. You will meet the main group at the departure gate in Vancouver airport.

Package C is a Land Package that includes domestic airfares within Thailand and Laos.

Final payment due date is 90 days prior to departure. You may be travelling on travel redemption points, or not travelling on the same flights with the group. You will meet up with the group in Bangkok hotel at the start of the tour. Your airport/hotel transfers in Bangkok are included when your flight arrangement is made with Canada One Travel. We are happy to source the best through-fare for you.

Failure to comply with payment requirement may result in automatic cancellation of the reservations and the refund of deposit less cancellation penalties will be made.
