LEADERSHIP WINNIPEG IS:

A program, run by The Winnipeg Chamber of Commerce and Volunteer Manitoba, that strives to inspire you to make a difference within yourself and your community.

Through 10 sessions from September to June, you'll share experiences that motivate and help you to develop an understanding of yourself, your community and your role in it. You'll be given a "backstage pass" to our city and be provided a unique, first-hand perspective on what's happening in our community. Leadership Winnipeg is also about making introductions and connections, and developing leadership skills and knowledge.

Leadership Winnipeg includes an optional second year of the program in which you have an opportunity to put what you have learned into action through Leadership Winnipeg Board Connect. Presented by the Winnipeg Foundation, this component of the program matches graduates with not-for-profit Boards or Board standing committees for a one-year ex-officio term leading to an advanced status of Graduation with Distinction and hands-on Board experience.

HOW TO APPLY

Selection criteria:

The Class of 2025-2026 will be selected based on a commitment to:

- Learning about our community - its challenges and assets
- Engaging in a process of self-awareness and personal development
- Accepting a community leadership role
- Taking part in Leadership Winnipeg Board Connect

A fundamental principle of Leadership Winnipeg is to ensure diversity and inclusion. The Class of 2025-26 will be selected to reflect cultural, life experience, age and gender balance between business, labour, government, voluntary and non-profit organizations and individuals in the community.

A maximum of FOUR participants will be accepted from any one organization or business.

Program Fees

- Chamber members: \$1,995 +GST. You must be employed by or own an organization that is a member of The Winnipeg Chamber of Commerce. If you are not sure, you can contact Ellen at ekornelsen@winnipeg-chamber.com.
- Regular rate: \$2,495 +GST. If you are interested in membership, please email estagg@winnipeg-chamber.com.
